Sindia is a Sovereign Socialist Secular Democratic Republic country which gained independence in the year 1947 with 29 states as of 2023. Sindian Democratic party and Sindian Conservative party are the two major political party in the centre. In 2023 Sindia surpassed its neighbour Mandrina in population and became the world's most populated country. As per UN there is tremendous growth in population with 0.8 % per year and will continue to top table till 2070. The literacy rate in the country has improved to 77% and contrary to the expectation this has not contributed to political participation. The voter turnout since 2018 general election is 65-70 % on average as against the 46% registered in the first general elections, which is disproportionate to the increased population and literacy in Sindia.

Sindia in 1947 to the surprise and criticism of many nation in the world, opted for democracy with universal adult suffrage right from the formation of the country. What was astounding was the fact that Sindia emerged as the largest and one of the successful democracy in the world and most of the credit goes to the Election commission and the set up which makes it a constitutional body. The election commission had updated the election process time and again to suit the pulse of Sindian scenario

However the election commission has its own share of issues like funding problem, increasing and fluctuating population, voter turnout etc. Till date, the country has seen 26 Chief Election Commissioners. The office of the Chief Election Commissioner is considered the most unstable, as in the past 10 years 7 Chief Election Commissioners have vacated the office before completing even 3 years continuously in office.

The opposition parties, during each election, have alleged the Government of political favourism and bias in the appointment of Election Commissioner. Especially in 2014, huge uproar came after the general election Chief Election Commissioner was immediately changed before the State election covering 7 states.

The Sindian democracy is also unique for its coalition both at centre and the state, while the constitution remains silent on it. In 1990s the first coalition alliance came to power in centre with National Independence Alliance lead by Sindian Democratic Party. The country witnessed same party rule in centre and state till 1970s, after which few states witnessed the rise of regional parties to the extend of exclusion of national parties too. Akalistan ,Thai Nadu and Mallunadu witnessed regional parties growth very strongly and other states joined later. However the fact that went on record was that no coalition government continued in office for a second consecutive term.

History was created by the Sindian Conservative alliance lead by the Sindian Conservative Party, when it won the election with sweeping majority in 2013, and in 2018 consecutively, with slightly less majority.

In 2023 election, 13 regional party formed an alliance namely National Liberation Alliance with Sindian Democratic Party and won the election grabbing 75% seats in Lok Sabha. The government came to power in January 2023 and immediately an Electoral Study Commission under former Supreme Court Judge Mr. Subba Rao was appointed to consolidate and study the electoral law and submit report. The commission studied, consolidated and submitted report in October 2023. Meanwhile the Chief Election Commissioner and 10 State Governors, were replaced by the central government in October 2023.

The opposition criticised this as the political tactics of the ruling party to influence the upcoming state assembly election scheduled to be held in 6 States of Sindia in November 2024 and 4 states in January 2025. In the midst of the criticism the government in line with the report by the Electoral Study Commission, within 6 months made the Constitutional and statutory amendments which received the assent of the President on 31st December 2023. The law minister held that "the amendment is the need of the hour in Sindia's journey to successful democracy with growing population". The government made the following amendment in the constitution marking the 106th amendment of the constitution of Sindia. The amendment is as follows:-

#### Amendment pertaining to appointment of Chief Minister

Modified-

Art 164 (1) - The Chief Minister shall be appointed by the Governor and the other Ministers shall be appointed by the Governor on the advice of the Chief Minister, and the Ministers shall hold office during the pleasure of the Governor:

Wherein no party won a majority the Governor shall in consultation with the Election commissioner call upon the party or pre poll alliance.

The article shall have overriding effect over any law prevailing pertaining to appointment of Chief Minister. Any law to the extent of inconsistency shall be inoperative.

Provided that in the states of Chandugraha, Ranji Pradesh, Madhya Sindia, Bhubaneswara, there shall be a Minister in charge of tribal welfare who in addition be in charge of the Scheduled Castes and backward classes or any other work.

#### Amendment pertaining to Election Commisssion

Modified-

Art 324 (2) - The Election Commission shall consist of the Chief Election Commissioner and such number of other Election Commissioners, if any, as the President may from time to

time fix and the appointment of the Chief Election Commissioner and other Election Commissioners shall, subject to the provisions of any law made in that behalf by Parliament, be made by the President by warrant under his hand and seal after consultation with Selection committee.

The Selection Committee will consist of the Chief Justice of Sindia or a Supreme court judge, Chief election commissioner in office, Prime Minister, and Leader of Opposition in both the houses.

(5) Subject to the provisions of any law made by Parliament, the conditions of service and tenure of office of the Election Commissioners and the Regional Commissioners shall be such as the President may by rule determine:

Provided that the Chief Election Commissioner shall not be removed from his office except in like manner and on the like grounds as a Judge of the Supreme Court and the Article 64 shall apply as to procedure of removal of chief election commissioner and the conditions of service of the Chief Election Commissioner shall not be varied to his disadvantage after his appointment.

The article shall have overriding effect over any law prevailing pertaining to Chief Election Commissioner. Any law to the extent of inconsistency shall be inoperative.

Added-

Art 51 A(l) - who is eligible to vote shall cast their vote.

Amendment Pertaining To Representation of Peoples Act 1951

Added

#### SEC 62 A - COMPULSORY VOTING

(1) All citizens eligible to vote shall vote compulsorily.

However the election commission shall be empowered to exclude certain classes or category of people from clause (1) with reasonable consideration and enlist the legitimate exceptions for non-voting.

- (2) The Returning Officer shall, at the close of each election, prepare a list of the numbers, names and descriptions as stated in the register of electors of such electors as have failed to vote at the election and certify the list under his hand. Notice shall be issued to the nonvoting elector.
- (3) A Special Court shall be constituted in every State in consultation with High Court for hearing challenges pertaining to non-voters. Matters pertaining to the number of courts, jurisdiction, procedure, limitation period, appeal and any other incidental matters shall be determined by respective High court.

(4) The non-voter on receipt of notice may challenge the validity in the election court and the Election commission shall institute case for non-voter with 4 consecutive notice. The non-voter has to provide a legitimate reason for his/her abstention to avoid further sanctions, if any exist.

**Sec 62B-**The non-voter with 4 consecutive notice shall be punished with fine or declared ineligible for application and employment in government jobs or non-issuance or confiscation of passport or Disfranchisement from the voters list.

The Provision shall have overriding effect over any law prevailing. Any law to the extent of inconsistency shall be inoperative.

Lot of uproar came in country calling amendment unnecessary, colorable and incomplete. The matter became a very big media sensation stating that the amendment as an early step for Sindia changing the constitutional structure and ambitions pertaining to Election Commission. Association for Democracy, an association founded in 1977 by a founding member and former Sindian Conservative Party member and Common Cause Association, an NGO challenged the validity of the amendment.

The matter is posted for argument before the Supreme Court of Sindia.

Whether the amendment pertaining to appointment of chief minister affects the constitutional position of Governor?

Whether the amendment pertaining to Chief Election Commissioner transgresses the constitutional limitations and principles?

Whether the amendment in the Representation of Peoples Act is constitutionally valid?

#### MOOT COURT RULES AND REGULATION

#### AIM AND PURPOSE

- a. The Central Law College National Law Moot has been conceived with the aim of creating opportunities for learning and development of jurisprudence on emerging trends in law besides developing cutting edge skills in research, writing and advocacy.
- b. Further, it is aimed to facilitate the evolution of the jurisprudential analysis of the laws and consequential emergence of new laws.

#### I. VENUE AND DATE

26th - 28th January 2024

#### **College Campus**

The Central Law College Yercaud Main Road, Kannankurichi, Salem, Tamil Nadu - 636 008.

#### II. LANGUAGE

The competition shall be in English language only.

#### III. Eligibility

Participation is restricted to bona fide undergraduate students of 5 years/ 3 years Law programme of any University/College/Institution (recognised by the Bar Council of India).

#### IV. Team Composition

Each Institution participating in the competition shall send a team consisting of two Speakers and one Researcher. In any case, the team shall not consist of more than 3 participants. Their travelling expenses shall be borne by the respective home Institution.

Each team will have a team code and each participant will be given an individual code. Team shall not disclose their identity or that of their institution or city etc. Such disclosures will invite penalties including disqualification. The decision in this regard shall be at the discretion of the Moot Committee.

#### V. Dress Code:

- For Boys-Black Pants, white shirt with Black Blazer.
- For Girls- Black Pants, white shirt with Black Blazer or white churidar suits with black blazer or white sari with white blouse and black blazer.

#### VI. Registration

- ➤ The Registration shall be restricted to 24 teams on first come first serve basis.
- > Only one team is allowed from each participating institution.
- The registration shall be a two step process- Provisional registration and Final registration.
- Provisional registration- the teams who are willing to register shall register provisionally with basic detail in the prescribed link:-

#### No Registration fees is required for provisional registration.

After provisional registration the moot court committee shall sent Final confirmation registration link via mail to be filled within prescribed time. Registration fee proof, prescribed registration form and bonafied certificate as in brochure shall be attached by the participant.

The team will be confirmed and considered registered only after completing the **dual process** within 28.12.2023 on first come first serve basis.

- Accommodation, local conveyance and hospitality for participants will be provided as specified in the rules.
- The participating team must submit the hard copy of Registration Form along with payment details, institution's bonafide letter on or before 30th December 2023.
- > The Registration Form should be sent by post to The Principal, THE CENTRAL LAW COLLEGE SALEM, Yercaud main Road, Kannankurichi (Po), Salem, TAMIL NADU 636 008. The travel form found in the brochure shall be sent along with memorial submission (1 Hard Copy) on 16th January 2024.
- After Registration, any request for change of name/ participants will not be entertained except at the sole discretion of the Moot Committee.

#### VII. ORIENTATION

There will be an Orientation Program for all the participants on the 26th January 2024 @4.00 pm followed by a draw of lots and Researcher Test . Team codes and side will be allotted during the orientation only. And the fixtures will be decided therein.

Researcher Test - The test shall be held after orientation and code allotment. The duration shall be 25 minutes with 20 MCQ question to be answered by the researcher of each respective team. Correct answer carries 1 mark and 0.5 will be deducted for wrong answer. Results will be declared in the Valedictory function.

#### A. ROUNDS

- i The Competition shall consist of two Preliminary Rounds, Quarter-final Rounds, Semi-final Rounds and Final Round. The top 8 teams from the preliminary rounds shall qualify to participate in the Quarter Finals. Winners of the Quarter-Finals will proceed to Semi-Finals. Winners in the Semi-finals will qualify for the Final Round.
- ii The team shall argue cases against each other. For the said purpose, fixture of team will be decided by draw of lots prior to the commencement of the competition i.e. on 26th January 2024 at the Central Law College Salem. The quarter final, Semi final and Final fixture and lots shall be drawn after result of each prior rounds.

#### B. Preliminary Round

- 1. There will be two preliminary rounds of arguments per team, once as Petitioner and Respondent each.
  - No team will face each other for more than once in the preliminary rounds.
  - Preliminary Rounds will be held on 27th January 2024. The duration shall be 15 minutes per team with 2 minutes for rebuttals and sur rebuttals
- 2. Top 8 teams from the Preliminary Rounds will advance to the Quarter-Final round. The basis of selection will be decided as follows:
- i. Win in both prelims with aggregate points in both rounds
- ii. One Win + Aggregate raw points in both rounds,
- iii. Team with maximum Aggregate raw points in both rounds
- iv. Team with maximum aggregate marks—Memorial marks (in case of tie)
- the criteria (ii) will be applied only when teams for quarter final couldn't be shortlisted as per criteria (i) in addition to team qualified under criteria (i)
- riteria (iii) will apply when required teams for quarter-final couldn't be obtained under criteria (i) and (ii) respectively, in addition to team qualified under criteria (i) and (ii)

3. Memorial marks will be added to the scores of all the rounds.

#### C. Quarter-Final Rounds:

- 4. During the Quarter Final rounds, the team will be required to argue either on behalf of the Petitioner or the Respondents. The teams to argue on a particular side will be decided by a draw of lots prior to the commencement of the Quarter final rounds
- 5. In the Quarter- Final Rounds, **each team** will be allowed **20 minutes** to argue. The division of time between the two speakers is left to the discretion of the team. In addition to the 20 minutes time allotted for arguments, 2 minutes will be provided for Rebuttals and 2 minutes will also be given to the opposite team for Sur-Rebuttal
- 6. The Quarter-final round will be a knockout round with a win enabling a team to get into the Semi-finals. Memorial scores will be added to the oral scores for this round where in the oral scores will be 100 marks.

#### **Semi-Final Rounds:**

- 7. During the Semi-Final rounds, the team will be required to argue either on behalf of the Petitioner or the Respondents. The teams to argue on a particular side will be decided by a draw of lots prior to the commencement of the Semi-Final rounds.
- 8. In the Semi-Final Rounds, **each team** will be allowed **25 minutes** to argue. The division of time between the two speakers is left to the discretion of the team. In addition to the 25 minutes time allotted for arguments, 5 minutes will be provided for Rebuttals and 5 minutes will also be given to the opposite team for Sur-Rebuttal.
- 9. The Semi-Final round will be a knockout round with a win enabling a team to get into the Finals. Memorial scores will be added to the oral scores for this round.

#### Final Round:

- 10. During the Final round, the team will be required to argue either on behalf of the Petitioner or the Respondents. The teams to argue on a particular side will be decided by a draw of lots prior to the commencement of the Final Round.
- a. In the Final Round, **each team** will be allowed **30 minutes** to argue. The division of time between the two speakers is left to the discretion of the team. In addition to the 30 minutes time allotted for arguments, **5 minutes** will be provided for Rebuttals and **5 minutes** will also be given to the opposite team for Sur-Rebuttal.
- b. The winner of the Final Round will be declared as the winner of this Moot Court Competition. Memorial scores will be added to the oral scores for this round.
- c. Participating team will be required to strictly follow the time limits for all the rounds.

#### VIII. RESULTS

Results of the preliminary rounds shall be announced after the completion of rounds of all the teams. Similarly, the results of the Quarter-Final/Semi-Final Rounds shall be announced after completion of the rounds. The results of the Final Round shall be announced in the Valedictory Ceremony. Attendance of all participants are mandatory on all three days including valedictory in formal attire.

#### IX. MEMORIALS

#### IX-A-Memorials/Written submissions:

- 1. All the teams are required to submit Memorials/Written submissions for both the petitioner and the respondent.
- 2. One advance soft copy of memorials (both Petitioner and Respondent) shall be submitted in pdf format on or before 11th January 2024 in the prescribed link-

- 3. Hard copy of the memorials (both Petitioner and Respondent) shall be sent along with **Travel detail** form on or before 16th January 2024. No excuses in respect of delayed post services shall be entertained. The memorials should be sent to the following postal address through speed post/Courier service only.
- 4. Late submission of soft copy or hard copy or both of the Memorials will be **penalized by 1 point** for each day.
- 5. Each team shall submit 5(five) hard copies of memorials, each for the Petitioner and Respondent. Names of the participants or their institutions or any kind of identification mark should not appear on any part of the Memorials.
- 6. Five copies of the memorials shall be submitted during the desk registration at 4.00 pm on 26th January 2024 at THE CENTRAL LAW COLLEGE, SALEM, TAMIL NADU. A covering letter must be enclosed (not attached) with the memorial (hard copy) specifying the name of the college/university of the participating team.
- 7. Participants are advised to carry extra copies of their Memorials for their own use. The copies submitted to the organizer would be for the use of evaluation of memorial and for the use of judges of the competitions and will not be returned to the participants.
- 8. After the completion of the competition, the organizers shall reserve the right to use the memorials submitted by the participating teams, as they may deem appropriate.
- i) The memorials should not exceed 25 typed pages (excluding front and back cover page)
- ii) The font size of the text of all part of the memorial must be in Times New Roman with font size 12. Footnotes must be in font size of 10.
- iii) The memorial must contain the following.

Cover Page for Respondent - Red Color

## The top right corner of the cover page of the memorials must contain the respective team code that has been assigned to the team

#### IX - B - Evaluation:

- a) Each Memorial will be evaluated for 10 marks (for each side ) and the Team memorial marks will be the memorial mark of the petitioner/respondent as per their position in the case.
- b) Memorials will be adjudged by a special panel of Judges.

The following will be the Evaluating Criteria and the marks will be allocated to each category as under.

#### X. AWARDS AND PRIZES:

Awards and prizes for the Moot Court Competition are as follows:

- 1. **Winners** of the Moot Court Competition will be awarded with a Winner's Trophy, mementos for team members and a Certificate of Merit.
- 2. **The Runners-up** team will be awarded with a Trophy, mementos for team members and a Certificate of Merit.
- Most Disciplined Team (1 team based on average court manners marks in all rounds) will be awarded with a Trophy, mementos for team members and a Certificate of Merit.

- 4. **Best Student Advocate Male** (Top male speaker) will be awarded a Trophy and a Certificate of Merit.
- 5. **Best Student Advocate Female** (Top female speaker) will be awarded a Trophy and a Certificate of Merit.
- 6. **The Best Researcher Award** (highest aggregate marks in the researcher Test), Top Researcher will be awarded with a Trophy and a Certificate of Merit.
- 7. **The Best Memorial Award** (highest aggregate marks of both memorial), Top team with highest mark of memorial, will be awarded with a Trophy and a Certificate of Merit.
- 8. Each participant in the Moot Court Competition will be awarded a Certificate of Participation. Participants shall attend on all days mandatorily from registration to valedictory in formals. Prizes and certificate shall be issued only in Valedictory and to the concerned participant only, attendance mandatory. Host institution shall not be responsible for their Certificates in case of absence.

#### XL SCOUTING:

- 1. Teams will not be allowed to observe the oral argument of other teams. Scouting is strictly prohibited.
- 2. The Researcher shall sit with speakers of his/her team at the time of oral arguments, but shall not attend the court session of any other team.

Further, the participants are strictly prohibited from contacting the framer of the moot proposition. Any attempt to do so will result in an immediate disqualification of the entire team.

#### XII. HOSPITALITY:

- 1. Accommodation will be provided to the members of the team, restricted up to three only, from 12:00 pm on 26th January 2024 up to 12.00 p.m on 29th January 2024.
- 2. Food and other facilities will be provided to the members of the team, restricted up to three only, i.e. the dinner of 26th January 2024 up to the lunch of 28th January 2024.
- 3. Local Conveyance (transport between the accommodation and the Competition venue) to the participating teams will be provided by the Organizers.

The Teams are required to report on 26th January 2024 at 4:00 pm at THE CENTRAL LAW COLLEGE ,SALEM for the Briefing Session, Desk Registration and Researcher Test during which Team codes will be given and Fixtures will be made (by lot). Participants must submit their memorials (5 sets) at the time of registration.

#### **FINALITY OF DECISION**
